#### 194 To receive apologies for absence

#### 198 To discuss the allotments

Cllr Aird said that aspects that affect Beverley are Bev-G (the Kitchen Lane housing allocation) is to be removed and Bev-P (amend Grovehill to retail and employment rather than just retail).
