31 To receive and accept apologies for absence

Apologies were received from Councillors Dodsworth and McGrath.

32 (a) To record declarations of interest by any member of the council in respect of the agenda items listed below. Members declaring interests should identify the agenda item and type of interest being declared.

Councillor Pearson declared a non-pecuniary interest in grant application from the St Mary's Beverley Church Lads & Church Girls Brigade as they are his Mayoral Charity.

(b) To note dispensations given to any member of the council in respect of the agenda items listed below.

Councillor Jack welcomed everyone to the meeting and explained the process.

Councillor Jack said the application forms were very informative and each representative would be invited to give a short presentation on their application. At the end of the presentations, applicants are able to leave the meeting whilst Councillors discuss the applications. Councillor Jack explained the funds available in the Town Council grants fund is 45% of the value of the applications received.

33 To consider the following Grant Applications:

Councillor Jack requested the application from East Yorkshire Broadcasting t/a Beverley FM be brought forward. All agreed.

(i) East Yorkshire Broadcasting t/a Beverley FM - £1560

Provision of 3 APC Smart-Ups to provide power during power outages and accidental incidents to keep Beverley FM on air (required because move from Longcroft School is required).

Power: LGA 1972 (Misc Provisions) Act 1976 s19

Discussion took place and members recommended that £1000 be awarded to East Yorkshire Broadcasting t/a Beverley FM.

Recommended – That the sum of £1000 be awarded to the East Yorkshire Broadcasting t/a Beverley FM.

(ii) R-evolution Horticulture Project - £1600

To contribute to a horticulture trainer £800, training and qualifications £200, marketing, insurance and transport £300 and equipment – tools/plants £300.

Power: Section 137

Discussion took place and members recommended that £1600 be awarded to the R-evolution Horticulture Project.

Recommended – That the sum of £1600 be awarded to the R-evolution Horticulture Project.

(iii) East Yorkshire Food Bank – £3000

Emergency safe and secure storage for food donations

£2400 for hire of storage and £600 for 6 sections of racking for storage

Power: Local Government (Miscellaneous Provision) Act 1976 Section 19

Discussion took place and members recommended that £625 be awarded to the East Yorkshire Food Bank.

Recommended – That the sum of £625 be awarded to East Yorkshire Food Bank.

(iv) Beverley Fringe Festival - £2000

Venue hire £700, Lighting hire for 3 events £900, Marketing £500, Accountancy Fees £300 and contribution to merchandise manufacturing £300

Power: Local Government Act 1972 Section 145

Discussion took place and members recommended that £1000 be awarded to Beverley Fringe Festival.

Recommended – That the sum of £1000 be awarded to Beverley Fringe Festival.

(v) Beverley Civic Society - £3000

Restoration of Town Pump

Contribution to 3d scans and mould creation, casting of replicas, fitting and specialist transport and fitting and final painting and plaque (£1362)

Power: Local Government Act 1972. S144 – Tourism

Discussion took place and members recommended that £1000 be awarded to the Beverley Civic Society.

Recommended – That the sum of £1000 be awarded to the Beverley Civic Society.

(vi) Beverley Town Bowling Club - £500

To contribute to the provision of 30 chairs for the Club

Power: Section 137

Discussion took place and members recommended that no funds be awarded to the Beverley Town Bowling Club.

Recommended – That no funds be awarded to the Beverley Town Bowling Club.

(vii) St Mary's Beverley Church Lads & Church Girls Brigade - £3000

Contribution towards cost of kitchen following refurbishment of HQ

Power: Section 137

Discussion took place and members recommended that £3000 be awarded to the St Mary's Beverley Church Lads & Church Girls Brigade.

Recommended – That the sum of £3000 be awarded to the St Mary's Beverley Church Lads & Church Girls Brigade.

(viii) Beverley RUFC - £3000

Contribution towards printing, security, toilets, waste management, stage, sound, lighting, medical provision, licence and advertising for Beverley Bestival 2019

Power: Power: Local Government Act 1972 Section 145
