- The Chair of the East Riding of Yorkshire Council has invited all Councillors to attend the opening of Rita Hunt Court on Burden Road on the 24<sup>th</sup> February 2015 at 11am. All Councillors are to inform the Town Clerk if they wish to attend to enable her to inform East Riding of Yorkshire Council.
- The Mayor said the Beverley Christmas Lights Appeal Group are holding an Evening of Song & Laughter on the 24<sup>th</sup> February 2016 at 7.30 at Beverley Town Cricket Club. Tickets priced at £12.50 to include supper.
